OBJECTIVE

The objective of this report is to provide the West Sacramento Area Flood Control Agency Board (WSAFCA/Agency/Board) with adequate information to extend the professional services contract with REY Engineers, Inc. for 13 months for the Sacramento River North Levee (SRNL) Project.

RECOMMENDED ACTION

Staff respectfully recommends that the Board:

Approve Contract Amendment No. 4, to extend the contract term with REY Engineering for 13 months.

BACKGROUND

The Sacramento River North Levee (SRNL) project is the next (third) increment of the Federal Project. WSAFCA is advancing preliminary investigations and work which will be utilized in the SRNL designs. This advanced work-in-kind counts as part of the non-federal sponsor's overall cost share for the Federal Project. At the December 16, 2021 meeting, the Board approved a professional services contract with REY for boundary, topographic, bathymetric, and related survey work. The Board also authorized the General Manager to execute contract change orders under an approved contract contingency of \$124,482.

In December 2022, the General Manager approved Amendment 1 for REY to produce profiles and cross-sections and consolidating LiDAR images, both tasks requested by USACE. Amendment 1 was for \$107,000 and deducted from the contingency. Amendment No 2 was approved by the Board at the March 16, 2023 meeting for \$72,270 for REY to conduct additional survey work, to incorporate areas from the Stone Lock Structure Gates through the Sac Bank Project along the Sacramento River. This work was an extension of survey work conducted for SRNL. Amendment 3 was administratively approved to re-allocate funds within the remaining contract budget to Quality Assurance and Quality Control for the remainder of the contract. None of the amendments modified the contract term.

ANALYSIS

The USACE has incorporated the survey data produced by REY for the SRNL design and has requested additional refinements due to some changes along the SRNL levee alignment and the desire to capture additional trees not surveyed in earlier submittals. As of this writing, the scope of work for the additional surveying services is still being discussed and the REY professional services contract is scheduled to terminate at the end of the calendar year (December 31, 2024). Staff is meeting with REY and the USACE to agree on the supplemental work and will return to the Board in January to request additional allocation of funds to carry out the work.

Alternatives

Staff recommends approving Amendment 4 to the professional services contract with R.E.Y. Engineers, Inc. for surveying services on the SRNL project. Alternatively, the Board may elect to not approve Amendment 4 with R.E.Y. Engineers, Inc. Staff does not recommend delaying or not approving the amendment 4 to the professional services contract with R.E.Y. Engineers, Inc. as time is of the essence to extend the contract term.

AMENDMENT No. 4 To the CONTRACT FOR SERVICES between the WEST SACRAMENTO AREA FLOOD CONTROL AGENCY and R.E.Y. ENGINEERS, INC. Dated December 16, 2021

This Amendment No. 4 to the Contract for Services between the West Sacramento Area Flood Control Agency (WSAFCA) and R.E.Y. Engineers, Inc. (Consultant), is made and entered into this 19th day of December 2024.

RECITALS

WHEREAS, WSAFCA entered a Project Partnership Agreement (PPA) with the U.S. Department of the Army acting through the Army Corps of Engineers (USACE) and the State of California Central Valley Flood Protection Board to construct the federal West Sacramento Project (Project) to improve the West Sacramento Levee System; and

WHEREAS, on December 16, 2021, WSAFCA and Consultant executed a Contract for Services for survey services for the Sacramento River West North Levee Project (SRWNL), an increment of the Project; and

WHEREAS, under the PPA, USACE may engage WSAFCA to perform locally led work to inform levee evaluations and improvement designs; and

WHEREAS, under the PPA, locally led work shall meet scope and requirements determined by USACE; and

WHEREAS, WSAFCA and Consultant executed Amendment No. 1 on December 31, 2022, and Amendment No. 2 on March 16, 2023, to provide additional survey work requested by the USACE for SRWNL; and

WHEREAS, WSAFCA and Consultant executed Amendment No. 3 on June 30, 2023, to integrate the task work product into the SRWNL 3D topographic model and base map; and

WHEREAS, WSAFCA desires to extend the contract with Consultant for an additional 13 months in order to allow sufficient time for Consultant to complete necessary work; and

NOW, THEREFORE, IT IS MUTUALLY AGREED by the parties hereto to amend the Contract as follows:

- 1. TERM: The contract term is extended to January 31, 2026.
- 2. NO OTHER AMENDMENTS:

Except as expressly set forth in this amendment, the December 16, 2021, Contract for Services remains in full force and effect.

REGULAR MEETING OF THE WEST SACRAMENTO AREA FLOOD CONTROL AGENCY November 21, 2024 Minutes

The meeting was called to order at 9:33 AM by Chair Tom Ramos. Vice Chair Sulpizio Hull was present. Director Alcala was absent. Chair Ramos presided. Also, in attendance were General Manager Greg Fabun, clerk Jenn Nguyen, staff Paul Dirksen, and Agency General Counsel Ralph Nevis.

Entry No. 1

Heard General Administration Functions as follows:

A. Report out on Closed Session

The Board met in closed session on two items listed on the closed session agenda. On the first item, the Board authorized a pre-condemnation offer on a parcel located at 4250 West Capitol Avenue for acquisition of a utility easement. On the second item, the Board authorized staff and counsel to initiate litigation to clear fee title to a property located in the Southport Levee Project.

B. Presentations by the Public for Matters not of the Agenda

None

C. Monthly/YTD revenue and expenses

Jenn Nguyen reported on the monthly revenue and expenses for September 2024. Fund 870's starting balance was approximately \$8.1M. The fund received \$3,800 from special tax assessments. Expenditures were \$35k. Fund 870's ending balance was approximately \$8.07M. Fund 871 had a starting balance of \$12.15M. The fund received approximately \$43k to offset a negative entry back in July and expenditures totaled \$161k. The ending balance for fund 871 was approximately \$12.03M. Including \$25M in the state advance fund, the Agency's combined cash position at the end of September was approximately \$45.1M. As of 11/12/24, the Agency's combined cash position was approximately \$45.28M.

Finance is currently closing out the books for FY23-24. The completion is anticipated sometime soon. The Corps received FY24 appropriations in June and a 5% cash request from the nonfederal sponsor is anticipated. Staff is currently working on RFMP packages through June 30, 2024, and Work In Kind packages 16 and 17, April 1 through September 30, 2024 for submittal to the Corps.

The Board acted on the Consent Agenda as follows:

Approved contract amendment 12 with Mark Thomas and Company for an extension of time, and authorization of the General Manager to take any and all actions reasonably necessary to complete the work described in the Contract.

Entry No. 4

Adopted Resolution 24-11-01, authorizing the Board Chair or General Manager, or designee, to enter into an agreement with DWR on behalf of the Agency and the Lower Sacramento River/Delta North Region, to receive grant funds, and to take all actions and execute all documents reasonably necessary to carry out the intent of the agreement.

Approved the minutes of the September 19, 2024, West Sacramento Area Flood Control Agency meeting.

B. Director comments

Chair Ramos presented a Proclamation to Greg Fabun for his achievements and services to the City of West Sacramento and the West Sacramento Area Flood Control Agency.

Vice Chair Sulpizio Hull expressed concerns about community misinformation regarding the City's levees and flood protection efforts. Vice Chair Sulpizio Hull recalled that staff previously planned to present updates to the City Council on the progress and efforts made in flood protection and emphasized the importance of moving forward with this presentation to disseminate accurate information promptly.

Finance is in the process of wrapping up FY 2023-24 with a 'soft close.' At this stage, the numbers are largely finalized, and we do not anticipate any significant changes.

Staff is currently working on RFMP packages through June 30, 2024, and WIK packages 16 and 17, April 1, 2024 through September 30, 2024 for submittal.

PROJECTS

SOUTHPORT LEVEE IMPROVEMENT PROJECT

<u>Real Estate Services</u>: The USACE has received credit packages for real estate for the levee, for the relocation of South River Road to Village Parkway, and for utility relocations. The USACE is completing its review of the property acquisition to verify the project is consistent with what the USACE would have acquired for the project. Staff will be engaging with the real estate team in the new year to work on crediting.

<u>Surveying Services:</u> This week we received approval of the Southport Record of Survey. The surveyor, Mark Thomas and Co. will submit the RoS to Yolo County for review and eventual recording. This is a major milestone for the project.

<u>Borrow One Site</u>: The property continues to be farmed by Viera Farms. Staff is currently exploring how this property could provide mitigation for the West Sacramento Levee Improvement Project.

SOUTHPORT RESTORATION PROJECT

<u>Maintenance and Monitoring</u>: River Partners completed re-plantings in the mitigation area to boost performance outcomes for the project. River Partners has removed the irrigation system for the season. GEI is in the process of drafting the 5 year monitoring report for the mitigation areas.

NORTH AREA PROJECT CLOSEOUT – All of the remaining rights needed for the I St. EIP have been acquired. Easement documents were sent to DWR and rejected. Some of the easement exhibits will need to be corrected. The I St. draft record of survey (ROS) has been submitted for review. The ROS will be updated with the remaining acquisitions which will also inform the legal description of the project's SSJDD joint use agreement.

FEDERAL PROJECT

<u>Project Partnership Agreement (PPA)</u>: The PPA was executed September 7, 2022, with a total project cost of \$1,173,819,000 shared 65% (\$762,892,000) federal and 35% (410,837,000) non-federal (NF). The NF share includes the estimated 5% cash requirement (\$58,691,000), estimated LERRDs (\$196,666,000) and estimated In-Kind Credit (\$155,480,000). The In-Kind Credit can be in the form of Section 221 Credit or WIK Credit, described below. All of the non-federal costs are shared 70% (\$287,585,900) State, 30% (\$123,251,100) WSAFCA. A table summarizing the Federal Project costs from the PPA, Federal and non-Federal Sponsor (WSAFCA and State) expenditures and remaining project costs is included at the end of the report.

5% CASH: To date, approximately \$6.14 million has been provided to meet the 5% cash requirement. With approval of the FY24 E&WD Bill, a cash request for approximately \$2.6 million is expected in the coming weeks/months.

LANDS, EASEMENTS, RIGHT-OF-WAY, RELOCATIONS AND DAMAGES (LERRDS) CREDIT: The first non-221 LERRDs credit package was submitted to the Corps for YBEL-N/S in the amount of \$237,038. This was for soft costs only as no land needed to be acquired for either reach. Staff continues to meet with the USACE real estate branch every month to discuss crediting packages and the activities that are eligible for LERRDs credit.

SECTION 221 CREDIT: Total credit submitted to the Corps to date is \$186.1 million. Packages #1 and #2 for Southport construction were submitted for a total of \$131.35 million. Packages #1 & #2 for Southport LERRDs were submitted totaling \$54.7 million. Additional credit packages for construction, real estate, and other costs (claims) will be submitted in the coming months.

WORK IN KIND (WIK) CREDIT: The Agency has submitted just over \$6.3 million in WIK credit to the Corps for project management and consultant services for design of YBEL-S and YBEL-N, and PED work on SRNL. WIK packages are submitted quarterly, and the above amount represents the total from packages submitted through March 31, 2024. The next WIK package will cover two quarters for work performed through September 30, 2024.

<u>Yolo Bypass East Levee South (YBEL-S) Project – Nordic (\$4M)</u>: Emergency repair work on the southern end of the reach began the week of October 28. The adjacent levee (berm) has been completed and the rock slope protection (RSP) has been removed and placed along the toe of the Tule Canal in preparation for the winter. The slope has been covered with visqueen, and secured with sandbags, using a method approved by DWR. This temporary remedy to the levee slope will remain for the flood season and until a complete remediation plan is approved by the USACE. The adjacent levee berm will likely remain in place and additional work on the waterside of the levee will be constructed next year.

<u>Yolo Bypass East Levee North (YBEL-N) Project – Odin (\$9.5M)</u>: The contract was awarded to Odin for \$9.5M on August 17 and the Notice to Proceed was issued September 5. Construction began May 1. The contractor is working with team and RD 900 to determine correct PG&E electrical needs for the pump station that will be installed as part of the project. WSAFCA staff have been negotiating with a property owner for a PG&E easement to provide power to the new pump station.

<u>Sacramento River North Levee (SRNL) Design</u>: The Corps held the design kickoff meeting for SRNL on August 10. Assisting the Corps with the design effort under contract is AECOM. SRNL is being broken up into 4 design/contract efforts. The figure attached at the end of the report shows the 4 anticipated contracts by number designated "S" = Seepage/Stability or "E" = Erosion Protection. The first effort, Contract 1S, will be in Segment 3. 30% design deliverable is June 2024. The USACE has released the 30% design plans to WSAFCA and the state for review.

GEOTECH: WSAFCA and BCI meet twice monthly with the USACE to coordinate the work. The H&H group has provided a design water surface elevation to enable the Corps to produce a draft Geotechnical Basis of Design Report (GBOD), a draft of which has been provided to the PDT for review. The GBOD will be updated with information from supplemental borings that were completed last month. This work will help inform the 60% design. Additional borings in segments

1 and 2 conducted by the Sacramento District's contractor are complete and lab results are pending

ENVIRONMENTAL SITE ASSESSMENT: Ninyo and Moore completed a preliminary evaluation of the Sacramento River West North Levee, including a database search for contaminated properties, site walk and review of permitting and construction records. The results indicate that where there has been an illegal release, the site has been remediated or is being remediated.

SURVEY: WSAFCA met with REY and the USACE to discuss additional surveying work that is needed for the Sacramento River North Levee. Additional field surveying of trees along the Sacramento River bank and adjacent to the levee alignment is needed to determine environmental effects and inform demolition plans.

<u>Stone Lock Preliminary Engineering and Design</u>
The Design Charrette was held Sep 28 to discuss potential alternatives to the GRR recommendation for the Stone Lock reach and to select a recommended alternative to move forward with for design. The recommended alternative consists of a bulkhead wall constructed west of the Eastern Sector Gate (final location TBD). The recommended alternative was reviewed and approved by the District Office of Council and the Change Management Board so it has been fully approved. The USACE has secured a contract with an A/E firm to complete investigations of the Stone Lock reach and develop a conceptual design by January 2026.

FLOOD INSURANCE

National Flood Insurance Program (NFIP) – Nothing to report.

FLOOD PLAIN ADMINISTRATION

Floodplain Management – Staff submitted the 2024 CRS recertification package to FEMA prior to the August 1 deadline. Confirmation of recertification was received November 1.

EMERGENCY PREPAREDNESS

Emergency Preparation/Flood Season Coordination – The 2024 preseason briefing and table top exercise occurred on November 14 at Station 45. Staff from all city departments participated and discussed storm and evacuation scenarios and available resources from city departments and the RD 900.

COORDINATION WITH OTHER ACTIVITIES

Regional Flood Management Plan – Regular meetings are ongoing. Once the agreement is executed, staff will bring an item to the Board to enter a new contract with MBK.
